**ACTION REQUIRED: Missing Photocopy of Identification**

Dear Voter,

We have received your voted ballot for the June 30, 2020 General Election. Under Colorado law, you were required to return a photocopy of acceptable identification (ID) along with your ballot. Unfortunately, your return envelope did not contain an ID.

In order for your ballot to count, you must return a photocopy of ID by the close of business on Thursday November 12, 2020. If your ID lists an address, it must be a Colorado address.

Return this form and the copy of your ID, if applicable, to the Adams County Elections Office by Thursday November 12, 2020.

**Use your mobile phone instead of the attached paper form!**

Adams County is providing its voters with an easier way to cure issues with their ballots by using their mobile phones. Just follow these simple steps:

1. Text the word Colorado to 28683 from your mobile phone
2. You will receive a reply text with a link to access the mobile system
3. Select the link provided in the reply to your text
4. Type in your Voter Identification number. Your Voter Identification number is printed above the barcode in the upper righthand corner of this letter
5. Complete and sign the remainder of the Affidavit displayed on your mobile device
6. Using the camera on your mobile phone, take a picture of an acceptable form of identification. The acceptable forms of identification are listed on the Affidavit
7. Select "Submit"

## 1. Select an appropriate identification

### Acceptable forms of Identification (ID)

Note: All IDs must be current and valid. If your ID shows your address, it must be a Colorado address.

A valid Colorado driver's license, except one issued to an individual that is not a citizen of the United States;	A valid student identification card with a photograph of the eligible elector issued by an institution of higher education in Colorado;
A valid identification card issued by the Department of Revenue;	A valid identification card issued by a federally recognized tribal government certifying tribal membership;
A valid United States passport;	A valid employee identification card with a photograph of the eligible elector issued by any branch, department, agency, or entity of the United States government or of this state, or by any county, municipality, board, authority, or other political subdivision of this state;
A valid United States military identification card with a photograph of the eligible elector;	A valid pilot's license issued by the Federal Aviation Administration or other authorized agency of the United States;
A valid veteran identification card with a photograph of the eligible elector issued by the United States Department of Veterans Affairs Veterans Health Administration;	Written verification that you are a resident of a group residential facility, are committed to the Department of Human Services, or are in the custody of the Department of Youth Corrections;
A valid Medicare or Medicaid card issued by the United States Health Care Financing Administration;	Written correspondence from the county sheriff or his or her designee to the county clerk indicating you are confined in a county jail or detention facility.
A copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows the name and address of the elector;	
Certified documentation of naturalization;	

## 2. Make a photocopy of that identification

If your identification shows an address, it must be a Colorado address.

## 3. Return the copy of identification

Return this form along with a legible copy of your ID to the Clerk and Recorder's Office by **Thursday November 12, 2020**. You may return it by:
